Kapusta Financial Group, Inc. (dba Kapusta Financial Group) is registered with the Securities and Exchange Commission as an investment adviser and, as such, we provide advisory services rather than brokerage services. Brokerage and investment advisory services and fees differ and it is important for you, our client, to understand the differences. Additionally, free and simple tools are available to research firms and financial professionals at <a href="Investor.gov/CRS">Investor.gov/CRS</a>, which also provides educational materials about broker-dealers, investment advisers, and investing. This document is a summary of the services and fees we offer to "retail" investors, which are natural persons who seek or receive services primarily for personal, family, or household purposes.

# What investment services and advice can you provide me?

<u>Account Monitoring:</u> If you open an investment account with our firm, as part of our standard service we will monitor your investments on a quarterly basis. If you engage us for a service other than Investment Management, we will not monitor your investments unless specified in the agreement you sign with our firm.

<u>Investment Authority:</u> We do not provide discretionary management services. We offer *non-discretionary* investment management services whereby we will provide advice, but *you will ultimately decide* which investments to buy and sell for your account. You have an unrestricted right to decline to implement any advice provided by our firm on a non-discretionary basis.

<u>Investment Offerings:</u> While we primarily recommend mutual fund shares and exchange traded funds, we also provide advice on various other types of investments, including equity securities, municipal securities, certificates of deposit, variable annuities, United States government securities, money market funds, and REITs. We may also provide advice on other types of investments as appropriate for our individualized investment advice.

<u>Account Minimums and Requirements:</u> We typically require a minimum of \$100,000, in aggregate, to engage our firm for Investment Management services. However, this minimum may be waived at our discretion.

# What fees will I pay?

The following summarizes the principal fees and costs associated with engaging our firm for investment advisory services. For detailed information, refer to our Form ADV Part 2A Brochure, Items 5 and 6 by clicking this link https://adviserinfo.sec.gov/firm/brochure/123349.

- Asset Based Fees Payable quarterly in advance. Since the fees we receive are asset-based (i.e.
  based on the value of your account), we have an incentive to increase your account value which creates
  a conflict especially for those accounts holding illiquid or hard-to-value assets.
- Hourly Fees Payable in arrears, as invoiced.
- **Fixed Fees -** Payable as invoiced, with one half of the fee due upon execution of the advisory agreement you sign with our firm.

Examples of the most common additional fees and costs applicable to our clients are:

- Custodian and account maintenance fees;
- Fees related to mutual funds and exchange-traded funds;
- · Transaction charges when purchasing or selling securities; and
- Other product-level fees associated with your investments.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

# What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

Because our revenue is derived from asset-based fees, we have an incentive to grow your account as
much as possible. This could cause us to take overly aggressive positions in conflict with your interests in
an attempt to grow your account, or could incentivize us to inflate the valuations of illiquid investments
held in your account.
